I understand that if this Application is favourably acted upon by CSIPL, the parties to the RSSA will be CSIPL, and either I or such other proposed business entity as CSIPL, consents to contract with and that CSIPL, will name in the RSSA the individuals upon whose participation in the ownership and/or operation of the proposed Retailership operations CSIPL, will be relying in entering into the RSSA.

In making this Application, I acknowledge and agree that :

1. The forms for this Application and questionnaire were supplied to me by CSIPL, as a convenience to me and their receipt by CSIPL, for consideration shall be without any obligation whatsoever on the part of CSIPL, or any of its representatives.
2. No one other than the VP- VSSM of CSIPL, has the authority to approve any proposal that may be subsequently submitted in support of this Application for the RSSA. Such approval, if given, will be only in the form of either: (a) a written RSSA on behalf of CSIPL, and the party named as "Retailer" in the introductory paragraph thereof, or (b) a written "Letter of Intent" to execute the RSSA executed on behalf of CSIPL, by the President of CSIPL, and accepted by me. Any action taken, expenditures made, or commitments assumed, by me, by anyone to be associated with me in the proposed Retailer company, or by the proposed Retailer company itself, prior to receipt by me of such written RSSA shall be at my or their sole risk and responsibility without any liability or obligation whatsoever on the part of CSIPL, or any of its representatives.
3. Neither I nor the Retailer company, which I may propose will be entitled to rely upon any representation or statement indicating approval of this Application made to me or anyone else by any representative or employee of CSIPL, or any other person whatsoever prior to receipt of the RSSA or an appropriate "Letter of Intent" executed by CSIPL.
4. Any material misrepresentation, whether intentional or unintentional, in the information submitted by me in connection with the Application or in the questionnaire shall be grounds upon which CSIPL, may either: (a) elect to no longer consider my application, or (b) immediately terminate any "Letter of Intent", or (c) immediately terminate any RSSA executed by GMI, with me or the Retailer company designated by me.
